Behavioral Health Continuum Infrastructure Program

Behavioral Health Continuum Infrastructure Program

• DHCS was authorized through 2021 <u>legislation</u> to establish BHCIP and award \$2.2 billion to construct, acquire, and expand properties and invest in mobile crisis infrastructure related to behavioral health. In partnership with Advocates for Human Potential, Inc. (AHP), DHCS is releasing these funds through six grant rounds targeting various gaps in the state's behavioral health facility infrastructure.

Community Care Expansion (CCE) Program

• The Community Care Expansion (CCE) program was established by <u>Assembly Bill (AB) 172 (Chapter 696, of Statutes 2021)</u> and will provide \$805 million in funding for acquisition, construction, and rehabilitation to preserve and expand adult and senior care facilities that serve Social Security Income (SSI) applicants and recipients, including those who are homeless or at risk of homelessness and people with behavioral health conditions. In partnership with AHP, CDSS will release a Request for Applications (RFA) in January 2022.

- Round 6: BH Needs Assessment Phase Two, \$480M (Round Opens March 2023) (Board & Care Retirement Buy Out)

What We Are Working On Now:

- 1. CCE Application **Hopkins Manor**, recently purchased by BHRS contractor that provides great enhanced service. Tentative agreement for **long-term lease** of 3rd floor as enhanced board & care, funds **rehab** 3rd floor and pay lease, **adds 46 new beds**. Application submitted.
- <u>2. BHCIP Application</u> **Construction** of a Methadone Clinic, addresses eminent closure of current facility and to avoid County becoming responsible to run program.
- <u>3. CCE Application</u> **Purchase** of existing Board & Care facilities to preserve beds and afford local operators the opportunity to retire and see their efforts continue. Also **rehab or expand** existing facilities.
- <u>4. BHCIP Application</u> **Acquisition and Rehab** of facility for a Youth Crisis Stabilization Unit and/or Youth Crisis Residential Facility.
- <u>5. BHCIP Application</u> **Preservation Funds** for capital improvements and operations subsidies that maintains the number of existing beds in the County. These funds will be administered by the Department of Housing. There is \$819,105 for operations subsidies and \$2,229,468 for capital projects.
- <u>6. CCE Application</u> **Solutions for Supportive Homes** is a community proposed housing pilot that diverts at risk persons with mental health disabilities before they become homeless. Targets socio-economically disadvantaged families and individuals that are non-English speaking.
