# Accessible County Facilities & Programs

- Working on updating San Mateo County's ADA Transition Plan:
- The County made a significant investment (approx. \$500,000) in 2018 to have Disability Access Consultants (DAC) update the County's ADA Transition Plan which included 81 facilities and 160 miles of public sidewalks in unicorporated San Mateo County.
- In September, the ADA Compliance Committee agreed to recommend the following projects for prioritization on the Capital Improvements Project list: Elysian Center, Canyon Oaks, Youth Service Center, North Fair Oaks Library, El Granada sidewalk improvements

2023-2024 Accomplishments

#### **Summary of Work Year-to-Date**

- In November 2023 committee began review of county owned and leased property list and identifying projects of interest for prioritization on the CIP
- Criteria for selection of recommended projects for the CIP included elements such as the volume of use, type of services offered, and availability of services elsewhere in the County
- Site visits were conducted at COB3, Cordilleras, Elysian Center, and Youth Receiving Home to consider areas of prioritization
- In September 2024 committee made its formal recommendation for projects to the CIP

#### Committee Goals

- 1. Advise the County's Commission on Disabilities and the Board of Supervisors on the accessibility needs of County-owned, or leased property and facilities. To work with all the departments within the County to assure equal public access to facilities and programs as defined by the Americans with Disabilities Act (ADA).
- 2. Help educate County employees about the ADA.

### Committee Objectives

- 1. Continue partnering and fostering a reciprocal relationship with the various County divisions in removing barriers throughout the County, these divisions include but are not limited to:
  - 1. Department of Public Works
  - 2. Health System
  - Human Services
  - 4. Elections Office
  - 5. County Executive Office (including Chief Equity Officer)
  - 6. County Parks
- Update the countywide priority list for removal of barriers
- Continue partnering with the Title II coordinator to draft a Transition Plan

Hate Crimes & Abuse Against People with Disabilities

- Abuse Roundtable Group (ARG), created in 2019 to address abuse against individuals with disabilities, established a workgroup to explore creating a statewide Caregiver Abuse Registry
- Workgroup developed and reviewed slide deck outlining need for a Caregiver Abuse Registry and shared with the ARG at May meeting
- Slide deck shared with State Council on Developmental Disabilities Bay Area Regional Advisory Committee at their June meeting
- San Mateo PD and Foster City PD presented updates on the Community Wellness and Crisis Response Team (CWCRT) program at May ARG meeting

2023-2024 Updates

- Committee focused its attention to the inclusion of disabled community in emergency services and response planning
- Coordinated Department of Emergency Management presentation to the entire Commission for June meeting
- Finalized disability needs survey to collect community input to share with DEM per their request
- Committee sent letter to the Board of Supervisors in support of CWCRT

#### Committee Goals

- 1. Continue to advocate for programs and policies that increase safety for individuals with disabilities.
- 2. Bringing people with disabilities to the forefront of DEIB efforts by the County.

### Committee Objectives

- Collaborate with members of the Abuse Roundtable Group to create a statewide caregiver abuse registry
- Working collaboratively with the DEM and other organizations to educate emergency responders about unique needs of disabled community members.

### Youth and Family

2023-2024 Updates and Accomplishments

- The Youth and Family Committee, along with several Transition Coordinators from various school districts, non-profit agencies, and state government agencies planned the 2024 Transition to Independence Fair
- Included career training, higher education, and job placement workshops
- Held at the San Mateo County Office of Education on February 10, 2024
- Over 235 attendees
- Meetings are currently on hold until more members can be recruited

- Advocated for improved transportation needs of residents in the Colma Veteran's Village housing complex.
- Encouraged Department
