As a property owner, tenant, or person with vested interest in the project vicinity, please be advised that the County of San Mateo Local Enforcement Agency (LEA) has accepted an RFI amendment application from Blue Line Material Recovery Facility and Transfer Station (Blue Line). The LEA is certified by the State of California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the County of San Mateo. This public notice is prepared and posted pursuant to Title 27, California Code of Regulations (27 CCR) § 21660.1.

Description of Project

The RFI amendment application package proposes the following changes:

- Minor revisions to language, formatting, and verbiage - for improved readability.
- New technology and upgrades to the existing MRF system to improve operational efficiencies that include new optic systems, automatic robotic sorting, and inclusion of new MRF figures and diagrams in the appendices of this report.
- General updates to the main body text to reflect a more current condition of the site (ex: changes to key management personnel, more current 2024 facility data, updates to regulatory text, etc.)
- Incorporate the Facility's Sampling Plan and applicable code sections incorporated as a result of SB 1383 regulation implementation.

Findings

The LEA has reviewed the proposed RFI amendment application -package and has determined that:

- The approved amendments do not require a permit revision and may be authorized through a RFI amendment.
- The application meets the requirements of 27 CCR § 21665 (c) and is approved.
- This approved RFI amendment is incorporated into the Transfer Processing Report (TPR) for the facility.

Appeals Process Information
