### CONTENT

#### **Efforts**

- Formal letters confirming participation to all existing (26) locations
- Numerous emails, calls to confirm participation and acknowledge responsibilities
- Utilization of internal sales tools to identify new opportunities to place kiosk drop-off sites and mailbacks
- On-site visits to existing mail-back sites
- On-site visits to potential kiosk locations
- Mailed signage with instructions for re-engaged and new mail-back sites
- More frequent touch points initial, 30 day, 60 day, 90 day.
- Revising mailback participation contract to Incorporating an acknowledgement that outlines program responsibilities and responsibilities
- Recalculation of convenience based on San Mateo County populations per district
  8 collection sites / mailback sites per district.

#### Progress & Outcomes

Inmar's efforts to regain convenience with the mailback program has steadily continued.

- Identified >600 leads working through/contacting for both services
  - o 96 declines
- Of the 26 original mail-back locations
  - 17 removed (requested removal, location closing, not enough participation, no returns, no desire to participate, unable to reach)
  - Still have 3 pending
  - Re-engaged 8 sites
- Added 40 new sites
- Continuous follow up for sites that have not returned anything.
- 47 confirmed active sites (re-engaged and new sites) unconfirmed sites are not included in this figure.
- New kiosk location (8/15/24):
  - o CHME Pharmacy 1101 B Chess Dr, Foster City CA 94404 (district 2)
- Meeting convenience in all districts


