Same Day Same Service Notes for Groups	Effective Now
<p>The claiming system has been updated to allow for group services to be documented in separate notes if more than one group was provided to the same client on the same day by the same provider. Individual service notes continue to require to be combined into one note if provided on the same day to the same client by the same provider.</p>

<p>Emails between BHRS and Edgewood no longer require encryption. This does NOT apply to any other contractor agency. All other emails outside of BHRS still require encryption.</p> <p>This is a friendly reminder to encrypt your emails by adding #sec# to the subject line of emails sent outside of BHRS.
